GIFT AID

HGS U3A is registered as a charity (no. 1182530) in England. If you opt to treat your membership fee as a Gift Aid donation, we can reclaim from HMRC 25p for every £1 received at no extra cost to you. To qualify for Gift Aid, you must be a UK taxpayer. In the case of two members at the same address living in a family relationship, both members' subscription can be treated as Gift Aid as long as the payment is made by a taxpayer.
