GIFT AID

HGS U3A is applying to be registered as a charity. Once we have registered, we can reclaim from HMRC 25p for every £1 received if you opt to treat your membership fee as a Gift Aid donation. To qualify for Gift Aid, you must be a UK taxpayer. In the case of two members at the same address living in a family relationship, both members' subscription can be treated as Gift Aid as long as the payment is made by a taxpayer.

I am a UK taxpayer and I want to Gift Aid my membership fee and any donations I make in the future to HGS U3A. I understand that if I pay less Income Tax and/or Capital Gains tax than the amount of Gift Aid claimed on my donations in that tax year. It is my responsibility to pay any difference.
